

**THE ARKANSAS STATE BOARD OF EDUCATION**

**PLSB CASE NO. 25-091**

**FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER**

At its regular meeting on March 13, 2025, the Arkansas State Board of Education (“Board”) accepted the recommendation of the Professional Licensure Standards Board Ethics Subcommittee (“Ethics Subcommittee”) for disciplinary action against the teaching license of Edward Butler (“Educator Butler”). Based upon Educator Butler’s failure to respond to the Ethics Subcommittee’s recommendation and the evidence presented, in accordance with the Administrative Procedure Act, Ark. Code Ann. 25-15-101 et seq., the Board hereby states as follows:

**1) Findings of Fact**

- a) The Arkansas Department of Education issued Educator Butler an ALT-EPP Provisional teaching license on August 1, 2024, valid until June 30, 2027.
- b) The Ethics Subcommittee received an allegation that Educator Butler violated the Arkansas Department of Education Rules Governing the Code of Ethics for Arkansas Educators promulgated pursuant to Ark. Code Ann. § § 6-17-422 and 6-17-428.
- c) On November 1, 2024, the Ethics Subcommittee authorized an investigation into allegations that Educator Butler violated *Standard 1: an educator maintains a professional relationship with each student, both in and outside the classroom; and Standard 2: an educator maintains competence regarding his or her professional*

*practice, inclusive of professional and ethical behavior, skills, knowledge, dispositions, and responsibilities relating to his or her organizational position.*

- d) Educator Butler was notified on November 4, 2024, of the Ethics Subcommittee's authorization to investigate this allegation.
- e) After considering the investigator's report and evidence on February 7, 2025, the Ethics Subcommittee unanimously found that a preponderance of evidence existed to substantiate violation of Standards 1 and 2 in that Educator Butler:
- Inappropriate interaction with student(s).
  - Inappropriate communication with student(s).
  - Exhibited inappropriate disposition inclusive of professional and ethical behavior.
  - Violated district, state or federal policies or law.
- f) The Ethics Subcommittee recommended that the State Board take the following actions:
- (1) Probation of License for 1 year;
  - (2) Assess a \$250.00 fine (due within 90 days of the State Board Order);
  - (3) Require Educator to complete the following coursework/readings:
    - (a) ERC23004: Code of Ethics Part One: Professional Relationships (.5 Credit Hour)
    - (b) ERC23010: Code of Ethics Part Seven: An Educator's Influence (1 Credit Hour)
    - (c) ERC23011: Code of Ethics Part Eight: Effective Communication (1 Credit Hour)
    - (d) Title: The Power Paradox: How We Gain and Lose Influence (208p)

    - (e) Title: Connect with Your Students: How to Build Positive Teacher-Student Relationships Author: Rob Pelvin ISBN-10: 1976797284


- (4) Educator to provide written reflections on each training/book on how they will impact the educator's future professional practices and interactions with students. Due to the PLSB for approval within 90 days of the State Board Order;
  - (5) Quarterly reports from the educator's supervisor regarding the educator's progress on professional practices and interactions with students; and
  - (6) Require Educator to pay all associated costs.
- g) On February 12, 2025, Educator Butler was notified of the Ethics Subcommittee's initial determination and recommendation by certified mail. Educator Butler failed to respond to the Ethics Subcommittee's recommendation thereby waiving his right to any further notice, hearing, or any other rights he may have under the Administrative Procedure Act, including those rights set forth in Ark. Code Ann. §§ 25-15-211 and 25-15-212.
- h) At today's meeting, the Ethics Subcommittee's recommendation and supporting documentation were presented to the Board as part of its consent agenda.

**2) Conclusions of Law**

- a) Upon consideration of the evidence presented at the meeting, Ark. Code Ann. §§ 6-11-105, 6-17-401, 6-17-422, 6-17-428 and 25-15-201 et seq., and the Arkansas Department of Education Rules Governing the Code of Ethics for Arkansas Educators, the Board adopts the Ethics Subcommittee's recommendations and enacts the sanctions accordingly. The Board admonishes Educator Edward Butler for his violation of the Code of Ethics.
- b) Educator Butler is cautioned that his non-payment of the assessed fine of \$250.00 may result in the suspension of his license until the fine is paid in full.

- c) Educator Butler is cautioned that further violations of the Code of Ethics or failure to pay the fine within ninety (90) days from the date of this order may result in more severe discipline including permanent revocation of his license.
- d) This order shall remain permanently in Educator Butler's professional licensure file and the confidential files of the Professional Licensure Standards Board.
